1	The total number of section of the school shall be restricted to 16. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by e laws and subject to the availability of room size of greater than 500 sq ft.	
2	There is variation in land area of the school, in part-A it is 12748 sq mt, in OASIS data total land area is 12748 sq mt, playground is 20720 sq mt and as per land certificate it is 8361 sq mt. The school is directed to apply on SARAS portal for correction of land area in OASIS.	
3	The concrete boundary wall is less than 6 feet in some places. Hence the school is directed to construct 6 feet concrete boundary wall in all sides and submit the compliance on SARAS portal within 3 months.	
4	The drinking water arrangement seems insufficient for the students and staff. No RO machines and water points are seen. Hence the school is directed to make sufficient drinking water facility available.	

5	The school has converted regular cubicles into CWSN toilets which are too small for the wheelchair/walker to enter and navigate.No CWSN toilets are ther on first floor.The school shall construct separate toilets for CWSN, boys and girls on every floor as per norms of RPwD Act and guidelines issued by the Board within 3months and submit compliance on SARAS.	
6	The library is undersized and understocked. The school is directed to set up library as per SoP issued by the Board and submit the compliance on SARAS portal within 3 months.	
7	As reported by IC & RC, there is no special educator appointed by the school. Hence the school is directed to appoint the faculty and upload the documentary evidence on SARAS portal within 3 months.	
8	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.	
9	The school shall complete the installation of lift within 3 months and submit compliance on SARAS.	

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be
