7. The management shall have power to delegate his powers and to determines the duties and responsibilities, salary of any one engaged by the Trust.
8. The Managing Trustee shall also have the power to contribute and maintain provident funds, gratuity and other funds for any employee and frame rules and regulations regarding the same.
9. The Managing Trustee shall have the power to deposit and withdraw the Trust money or any portion thereof in any Nationalised Bank or Banks, either by way of fixed deposits or in the current account & savings account etc .and operate account jointly with any other member Trustee as nominated by Founder Trustee.
10. The Managing Trustee shall have the power in general to acquire all things and to do all acts which are necessary to carry out the objectives of the Trust.
11. The Managing Trustee shall be to borrow with the concurrence of Founder Trustee or secure the payment of grants from Government or any other person or public body for the purpose of the Trust . Have powers to sell. change and deal with the whole or part of the assets of the Trust in such a manner and upon such terms and conditions as given by the Founder Trustee for each transactions or activities in particularly by mortgage or by creating charge on any immovable properties of the Trust.
12. All documents relating to the properties or to any loans secured by the Trust as aforesaid, shall be executed for on behalf Trust jointly by Two Trustees one of whom shall be Managing Trustee.
13. All properties belonging to the Trust hereinafter to be acquired in furtherance of the objectives of the Trust shall be under the control, guidance and supervision of the Managing Trustee.


POWERS OF THE MEMBER TRUSTEES:

1. Any Trustee cannot delegate his office or any of his duties to co-trustee or any other stranger.
2. Trustee may not use or the deal with Trust property for his own profit or for any other purpose unconnected with the Trust.
3. Any Trustee may at any time invite and receive or without such invitation receive any voluntarily contribution or contributions from any person or persons by way of donations, legacy or otherwise . All such contributions shall be treated as forming part of the Trust Fund.
4. A Trustee shall be disqualified from acting as Trustee, if he becomes or declared to be insolvent or of unsound mind, whether or not found by inquisition or otherwise become unfit or incapable to act.
5. Any Trustee who collects money from any source as stipulated in clause (i) infra, shall deposit the same into Account of the Trust as early as possible.
6. Member trustee shall keep accounts with respect of all sum of moneys received and spent by them and shall submit it to the Managing Trustee for approval






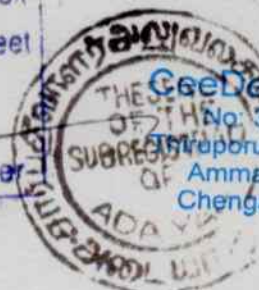
2. The funds of the Trust would be utilized only towards advancing the objectives of the Trust and no portion of the said funds would be distributed in any manner to the Trustees or any other persons defined in sec 13(i) (c) of the Income Tax Act 1961.
3. The accounts of the Trustee would be maintained regularly and would be audited by a Chartered Accountant
4. In case of winding up or dissolution of the trust the net funds of the Trust shall be transferred to institutions having similar objectives and enjoying exemption under sec 11 and 80 (g) of the income tax act 1961
5. The activities of the Trust would be confined to the territory of India
6. Alienation of the immovable property of the Trust shall be done with prior approval of the Director of Income Tax (Exemptions) Chennai.
7. It is considered that the objectives of the Trust will be better achieved if income of the Trust and donations to the trust are exempted under income tax.
8. In case, however, a particular clause of the Deed of the Trust has inadvertently inserted or capable of causing interruption to the activities of Trust or in conflict with the income tax act, it is expressly declare that, the clause or clauses shall restricted meaning or treated null and void.
9. At present the Trust does not own any movable, immovable properties except the corpus fund of Rs 25000/- (Rupees Twenty five thousand only).



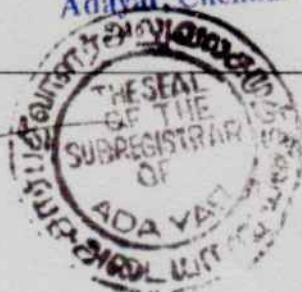
